In any case Fairview Park Chamber of Commerce assumes no liability for lost or stolen merchandise.

Exhibitor Responsibility: Exhibitor shall be solely and completely responsible for the erection and removal of its exhibit and operation of its assigned display area, and shall hold Fairview Park Chamber of Commerce, its members, agents and servants harmless for all liability which may result either directly or indirectly from said activities.
